### **ANNAPOLIS FRIENDS MONTHLY MEETING (AFM) MEETING FOR WORSHIP WITH ATTENTION TO BUSINESS (MFB) NINTH MONTH, FIRST FIRST DAY, 2016**

**Opening:** We began with centering worship. Our Clerk thanked Friends for attending MfB despite the holiday weekend.

#### **1. Misc short notes and calendar items:**

Our Clerk noted that he circulated Minutes from a recent semiannual **Clerks Meeting**. (See attached.)

**2. Our Black-Lives-Matter ("BLM") banner has reached its one-year anniversary**, noting this, our Clerk asked if Friends were comfortable joining St. Philips Episcopal, Unitarians & others in transition to a new banner reading "Dismantle Racism: Join the Conversation."

One Friend noted that the new anti-racism banner is broader than the BLM banner as it is not limited to African Americans. Others agreed the new banner is a more positive statement. A third Friend suggested AFM should designate a committee with authority to maintain and replace a banner, if needed. Yet another comment was made that, because any banner on our dead end street does not get much public view, Friends should consider how to support this concern in the community. Another Friend suggested we should not wait for a "successful" destruction of our BLM banner, but should join with other communities that have adopted the new banners and hold our current BLM banner for appropriate occasional use.

Friends initially agreed to refer these concerns to AFM's Deconstructing Racism workgroup. Mary D. raised questions about her informal role as a representative or liaison for AFM in BLM campaign organizers' discussions. Barb T., for PSC, reported that this committee would agree to offer care & seasoning for her Mary D.'s efforts. We agreed to continue displaying the current banner, pending further discussions in our committees. 2

**3. Memorial Minute for Joel Rodkin** – For M&W, Martha O presented a memorial minute. (See attached.) Friends came to unity and approve this Minute.

**4. Treasurer's Report** – Our Treasurer (Sue P.) presented a financial statement for the first 8 months of 2016, noting that our receipts and proceeds are "pretty normal" and we are somewhat ahead of last year's contributions and rental income. Friends thanked our Treasurer for her work on this report. (See attached.)

**5. 2017 Budget Kick-off** – For Stewardship and Finance Com. ("S&F"), Karen C. reminded Friends we are kicking off the budget season. All committees are asked to send requests for the coming year so S&F can "smoosh these into a budget" and bring this back to MfB in November.

**6. Nominating Committee is expected to propose making the Market Committee a standing committee**, our Clerk noted, although this is not expected to require more Friends. A friend of Cairn reportedly is willing year round to take antiques or large items on consignment for the benefit of AFM. He thanked Friends for their various Committee efforts.

**7. Ministry & Worship ("M&W") Committee:** For M&W, Martha O. announced various items, including:

**a. A new ad hoc subcommittee, called the "Green Team(GT),"** was approved at the recent Clerk's Meeting to replace our recently disbanded "Ad Hoc Growing and Greening Committee" (now reconstituted as our "Building for the Future (BFF) subcommittee). Martha O. and Phil F., as GT coclerks, invite interested Friends of all ages and from all committees to participate.

(MHL & M&W will be asked to consider which committee should take this new subcommittee under its care.)

Joining with the national GreenFaith campaign, BYM's Unity with Nature, and other faith communities, GT will consider checklists to confirm our Meeting House's qualifications to become a "Green Sanctuary" as the first GreenFaith-affiliated Quaker meeting in the U.S., as well as making recommendations for more practical steps towards best practices in our "Care for Creation."

GT invites all to read a document called "Living in a Hinge Time," to meet on Sep 6 at 7-9 PM, and to consider the urgency of GT's mission. (See attached.)

**b. Request for \$500 for West River Quaker Burial Ground (WRQBG):** Martha noted that M&W, in years past, maintained a budget line-item for an annual donation to the West River Burying Grounds. But, we have not contributed in at least 5 years. M&W asked meeting to approve an immediate donation from the Emergent Social Concerns Fund or the Committee Contingency Fund, noting its plan to add the same amount as an annual donation to its budget request in 2017 and subsequent years. Our Clerk noted that up to \$500 may be spent from our Committee Contingency Fund without formal MfB approval. Friends approved making this a part of our budget.

**c. At our recent meeting for learning on vocal ministry**, Friends rejoiced to deepen our understanding of vocal ministry in Meeting for Worship. Via weighty texts provided by Outreach, we considered the wisdom of many voices in our query.

Most notably, we were encouraged to courageously speak our vocal ministry, even if it not completely seasoned and eloquent, if it felt like a message for the gathered meeting. We also were admonished to welcome the imperfect vocal ministries of other Friends, and to allow the Spirit to "add on" to the message as Meeting progressed, thus using many Friends to complete it. 3

We also embraced the admonition to be good Listeners to the vocal ministries, to take in the message wholeheartedly, then to let God apply it to our hearts to determine its application (or not). We were encouraged to let a message

which seems inapplicable to us to “run off our shoulders like water off a duck.” (Additionally, copies of the pamphlet “Silence and Speech” are available in the lobby.)

After this MFL, two Friends offered further suggestions for M&W to consider: writing the new learning as queries, and continuing our study of Spirit-led worship. M&W will pursue these matters in our committee meetings.

In the fall, M&W will offer a meeting for learning on the “Four Doors of Meeting for Worship”, a Pendle Hill pamphlet, describing how we can prepare, during the week, to help ourselves grow and to have a truly “gathered meeting” on First Day.

**8. Peace and Social Concerns: Peace & Justice Center (P&JC)**, Martha B. offered an update to Friends on the outcome of steps that P&JC has held for us to educate ourselves on immigration issues, including individual research, attending meetings at Sandy Springs, and meeting with representatives of the First Presbyterian Church, Annapolis that “adopted” an Iraqi immigrant family via the World Relief organization.

While P& JC has not, as yet, reached unity on a single project or leading, Martha provided various community and govt. programs in an “opportunity chart” titled “**How might you help?**” If there is an activity on the list (attached to these minutes) that interests Friends, P&JC can assist Friends in learning more about the organization and how to connect with the opportunity. As individuals become more involved, it may help our Meeting discern additional directions. Friends thanked PJC members for their work so far.

We recognized that we had insufficient remaining time to allow for the full consideration of items from P&SC.

Consequently some additional items were either postponed to next Business Meeting, or may be handled via e-mail if they allow.

### **9. Other Items:**

**a.** MarthaO also offered some **additional calendar items** (included above).

**b.** A Friend noted she still is **not receiving email via the “Announce List.”** As a stopgap, Wes and Meeting clerks have been sending Announce emails to an ad hoc list of cc’s for people not receiving the Announce list items. Wes agreed to re-send Announce to this group on a regular basis, and some clarification of its status and use.

**Closing:** MfB closed with silent worship transitioning into MfW.
